



Credit Union EventPlex Facility Use Policy

Effective April 4, 2009

- Caution should be exercised when walking by or standing near the protective perimeter netting used in the Credit Union EventPlex. The barrier provides a measure of protection but will not completely resist the impact of a kicked ball or player(s) crashing beyond the boundary of the field of play. All users of the Credit Union EventPlex should be aware that the protective netting can be deflected three feet or more if impacted with great force. Spectators must insure they maintain a safe distance to prevent contact with objects or persons that extend beyond the playing area.
- Parents are responsible for the conduct, behavior and safety of their children. Children must be supervised at all times.
- Metal cleats shoes are prohibited from use on the soccer turf.
- Only water is allowed on the turf. Sport drinks, alcohol, juices, coffee or other liquids, not listed, are prohibited in the playing area. Garbage and plastic water containers are to be disposed of in the receptacles provided. Please respect the playing area.
- Chewing gum or chewing tobacco products are not allowed in the Credit Union EventPlex playing area, spectator area or locker rooms. Persons using such products will be held responsible for any cleaning or replacement deemed necessary because of their use.
- Spills of blood, spit, vomit or any other body fluid(s) or matter that may present a Bio-hazard must be reported immediately to the Credit Union EventPlex or Evraz Place staff.
- Spitting on the turf or an opponent will not be tolerated and can result in ejection from the facility and a minimum 18 game suspension for a first offense.
- Shell seeds, pistachios and shell peanuts are not allowed in the Credit Union EventPlex.
- Entering and exiting the playing area is only permitted at the half field opening. Participants crawling through or under the protective netting may be ejected.
- A \$20.00 deposit or set of car keys is required to obtain a dressing room (key). Dressing rooms will be inspected for cleanliness and damages before the deposit is returned. Teams are responsible to leave dressing rooms in a tidy condition. Teams are responsible for any damages to dressing rooms, however caused. Teams not returning dressing room keys within ½ hour after the scheduled event has ended will lose their deposit.
- Participants or spectators found responsible for willfully damaging, defacing, destroying or theft of Regina Soccer Association, Regina Exhibition Association, Credit Union EventPlex, Evraz Place or personal property of other users of the facility will be held responsible for all repair or replacement costs and will be subject to loss of entry privileges.
- Do not leave any valuables in the change rooms or unattended in the public area. The Credit Union EventPlex is not responsible for lost or stolen articles.
- Spectators are not allowed on the turf playing surface. There is seating provided to watch activities from behind the protective netting.
- Use of compressed air powered horns, boating safety horns or any noisemaking devices that are deemed to be excessive are prohibited from use in the Credit Union EventPlex.
- Vehicles parked in wheel chair access ramps will be towed immediately. Vehicles parked in designated handicapped parking areas without permits will be towed immediately. Any vehicles parked in a manner that creates unsafe conditions for our patrons will be towed. No exceptions.
- Pets and animals are not allowed in the Credit Union EventPlex.
- Use of the Credit Union EventPlex for activities other than originally contracted for will result in termination of the rental agreement and future access may be denied
- All users: you are entering one of the finest facilities of its kind in Saskatchewan. Please respect the rules of occupancy and help us keep this facility clean, safe and comfortable. Please use the litter receptacles provided and report any dangerous situations immediately.
